I hope you have been enjoying this mild winter. I suspect we will get one snow fall before the end of winter.

I am sure that those of you who use Pleasant Valley Dr. (PVD) have noticed the new Traffic Calming speed humps. Three years ago, two Woodbridge Valley residents, Anthony Marsiglia and Joseph Striedl, who live at opposite ends of PVD and independent of each other, began the process of getting the County to add Traffic Calming measures to PVD. To begin, the County had to decide that the street was eligible for Traffic Calming. Once that happened, the hard part began. Mr. Marsiglia and Mr. Striedl had to get signed approval from a certain percentage of the residents on the street to allow the County to add Traffic Calming devices to PVD. In May 2011, Board Member Nicole Smoot, who also lives on PVD, joined the effort to get the project completed. With the help of Deborah Ball and yours truly, all of the paperwork finally got processed to the County, which was then able to do the work this past January. The details are in an article in this newsletter. Thank you to all who played a part in completing this project.

Open Burning

What is “Open Burning” and when does it violate Zoning?

Over the past summer and fall the Association has received various inquiries regarding residents burning leaves, trash, construction materials etc. and what can be done to lessen the impact on neighbors. After several inquiries of our own and those of several residents to a variety of Baltimore County agencies (fire, zoning enforcement, & environmental concerns), the following is a summary of Baltimore County definitions, and classifications of “Open Burning.”

Restrictions on Chimineas and Fire Pits

The use of outdoor wood-burning heating appliances — fire pits and terra cotta chimineas — is increasingly popular, especially during the early autumn months. The Baltimore County Fire Department encourages residents to know the rules about these devices and to take appropriate safety precautions.

Chimineas, fire pits and outdoor metal heaters are specifically designed to burn seasoned wood, the same as any wood-burning stove. They are subject to the same fire code restrictions as gas and charcoal grills:

- They are not allowed on balconies or within 15 feet of multi-family buildings, including apartment buildings.
- They are allowed only on property occupied by one- and two-family dwellings, including townhouses.
- The devices cannot be used to burn trash.

The Fire Marshall’s Office cites restrictions on Outdoor burning in the Fire Prevention Code 1:10, 11

Outdoor burning is allowed in Baltimore County outside of the Baltimore Beltway (I-695), but the property owner must obtain a burning permit authorized by the Environmental Health Division of the Department of Environmental Protection and Resource Management. The permit must be kept at the site during the time of the burning. If Environmental Health does not authorize the burn, no permit is issued and the burn becomes a violation of the fire code.

Burning is not allowed within fifty feet of any structure and if necessary additional distances may be required by the Fire Department, Forest Service, or Environmental Service. The property owner must also take steps to prevent the fire from spreading to any structure, such as having a water supply available.

Open Burning (continued)

Outdoor solid fuel (firewood) burning boilers

There are situations which do not fit neatly into the above categories of "open burning" such as a recent incident in Woodbridge Valley regarding outdoor solid fuel burning boiler used to supplement the heating of a house. Concern with the smoke and seemingly toxic fumes emanating from the boiler, several residents pursued the matter with several county agencies. The county has determined that a permit must be obtained before an outdoor solid fuel boiler is approved.

Summary of the Guidelines

Fire pits and terra cotta chimineas are sanctioned by the county for heating small outdoor areas and come under the same fire code restrictions and common sense usage as gas and charcoal grills. Outdoor burning used to heat the interior of a house is in violation of county fire code and environmental restrictions.

Speed Humps

Cars often travel on Pleasant Valley Drive well above the speed limit. There have been numerous accidents and several near missed accidents. Residents who live on Pleasant Valley Drive expressed concerns and desired a resolution. Baltimore County assessed the traffic and concluded that the street qualified for traffic flow devices – speed humps. Before installation could begin, however, over 100 signatures were required to approve the project. Gathering the 100 plus signatures took well over two years. Over 110 signatures were obtained this past fall.

The installation of the speed bumps began in January 2012. Originally, Baltimore County approved 9 humps to be installed. During the week of the installation, additional neighbors expressed interest in having speed bumps placed in front of their homes as well. Within 24 hours, these neighbors signed the petition and two additional humps were approved. There are now 11 speed humps on Pleasant Valley Drive, and there is definitely a noticeable difference in the flow and speed of traffic. Thanks to everyone who signed the petition.
