SEMI-TRAILER TRUCKS IN YOUR NEIGHBORHOOD?

Over the past year various residents in Woodbridge Valley have had to put up with the inconvenience of having a semi-trailer truck (with a 53 foot Trailer) parked near or in front of their houses.

Woodbridge Valley along with other community organizations lobbied the Baltimore County Council to enact legislation to discourage this intrusive parking. As a result of this petitioning, on August 1, 2016, our Councilman, Thomas Quirk and the Baltimore County Council passed Bill No. 52-16, An Act Concerning Parking which went into effect September 19th.

For parking a tractor, trailer, or tractor trailer in a residential zone (Woodbridge Valley) the person violating this bill is subject to a fine of \$250.00 each for the tractor or trailer and \$500.00 for a tractor and trailer, in combination, for each day the violation exists.

If you see a tractor-trailer parked in Woodbridge Valley, call 410-887-2222, and the Baltimore County police will ticket the tractor-trailer.

DID YOU KNOW????

The Baltimore County District Courthouse located on Wilkens Avenue is relocating to Rolling Road in 2018. The new Courthouse along with a parking garage will be built on the vacant lot behind the professional building at Johnny Cake and Rolling Roads. The Courthouse will have 5 floors with 8 courtrooms. There are also plans to house other State Agencies, such as the Public Defender's Office and Parole & Probation, within the building as well.

THINGS YOUR BURGLAR WON'T TELL YOU

7. A good security company alarms the window over the sink. And the windows on the second floor, which often access the master bedroom - and your jewelry. It's not a bad idea to put motion detectors up there too.
8. It's raining, you're fumbling with your umbrella, and you forget to lock your door - understandable. But understand this; I don't take a day off because of bad weather.

10. Do you really think I won't look in your sock drawer? I always check dresser drawers, the bedside table, and the medicine cabinet.

2. The two things I hate most; loud dogs and nosy neighbors.
