The Drug Enforcement Administration (DEA) has scheduled another National Prescription Drug Take-Back Day for **Saturday, September 29, 2012, from 10:00 a.m. to 2:00 p.m.** Two nearby drop-locations are the Woodlawn Precinct, located at 6424 Windsor Mill Road, Woodlawn, MD and the University of Maryland Baltimore County Police Station, located at 1000 Hilltop Circle, Baltimore, MD 21250. This is a great opportunity for those who missed the previous events, or who have subsequently accumulated unwanted, unused prescription drugs, to safely dispose of those medications. RECYCLING AND REUSE NEWS

Help the environment and people in need. Baltimore County's Reuse Directory is available online at www.baltimorecountymd.gov/recycling. This publication lists groups, nonprofit organizations, and businesses that accept items such as appliances, beds, building materials, cell phones/accessories, clothing, computers, furniture, medical equipment/supplies, sports equipment, toys, and more. Hard copies will also be available by calling 410-887-2000 or by e-mailing to recycle@baltimorecountymd.gov.

Household Electronics & Hazardous Waste Recycling & Disposal Day will be held on Sunday, November 4, 2012 from 9 a.m. until 2 p.m. at the Western Acceptance Facility located at 3310 Transway Road in Halethorpe, MD 21227. Baltimore County residents may drop off unwanted household chemicals, paints, pesticides, medicines, mercury thermometers, fluorescent bulbs, rechargeable batteries, computers and home electronics, ammunition and automotive fluids for recycling or proper disposal. No trash will be accepted during this event.

FALLING TREES

As the Woodbridge Valley community matures, so do the trees. In recent years, the Association has been involved with the issue of decaying and falling trees. The Woodbridge Valley Covenants do not address the issue of trees, so here is a summary of Baltimore County government's policy and practices concerning trees.

Private Property – If a home owner feels that a neighbor's tree represents a hazard to property or life, it is the home owner's responsibility to notify the neighbor in writing about the tree hazard. The home owner should also notify his or her insurance company of the hazard and the steps taken to notify the neighbor. Baltimore County will not tell or dictate to a property owner what to do with a tree. In fact if the neighbor's tree falls on the home owner's property and the home owner has not notified the neighbor in writing about the potential hazard, the home owner is responsible for cleaning up the debris in his or her own property.

Baltimore County Property – Most of the property owned by Baltimore County is under the auspices of either the Baltimore County Department of Recreation & Parks or the Bureau of Highways.

- If a plot indicates a section of land as Open Space that land will be under the control of Recreation and Parks. If a tree from Baltimore County Open Space is a threat to your property, call 410-887-3871. The County will not address any fallen trees but will cut down a tree that is a threat. The tree cut down by the County will not be removed.
- Trees that are a hazard along a County street or road will be addressed by the Baltimore County Bureau of Highways. Call 410-887-3300, which is the Baltimore County Department of Public Works. From there, you will be directed to the Bureau of Highways.

ANIMAL LICENSING

All dogs and cats four months of age or older and kept in Baltimore County for longer than 30 days per year must be licensed annually. The license period is July 1 through June 30 each year. You must renew your license each year by July 31 to avoid penalty fees.
